Autoship Program Terms and Conditions



This Program is an arrangement by which an Organic Vision ("OV") distributor (the "Independent Distributor") becomes a participant of this Program and places a continuing order for a Pre-Selected Autoship Default Products to be paid by his/her or immediate family member's credit card. By signing this Agreement, the Independent Distributor ("I") agree to the following terms and conditions ("these Terms and Conditions"):

本計劃乃一項供機滙直銷商(「獨立直銷商」)參與·並透過使用其本人或直系親屬之有效的信用咭持續付款購買預選產品的安排。本合約一經簽署·有意參與本計劃的直銷商(「本人」)同意遵從下列條款與規章(「此等條款與規章」):

- 1.I understand and agree that I must be 18 years old or above to sign this Agreement. I shall show and hand in my identity documents to OV for verification. I understand that if I refuse to hand in identity documents, my application for OV Autoship program may be accepted or rejected by OV at its sole discretion. 本人明白並同意參與本計劃必須年滿 18歳。本人將向機滙出示及遞交身份証明文件。本人明白如本人拒絕遞交身份証明文件或資料、機滙絕對有權接受或拒絕本人申請。
- 2.1 will fill in the Autoship Amendment Form and come to the Office to pay for my Next Autoship order or I will use the Backoffice Autoship Amendment page to pay for the Next Autoship purchase order, provided that any amendment must result in a BV the same or higher than 680BV. 本人會填寫更改自動購貨申請表及前往公司櫃位繳付或會用電子商務的更改自動購貨版頁繳付我下次自動購貨訂單,而所提出的任何更改,最終會符合總業績額會達到680 BV或以上的要求。
- 3. If I have elected to collect the Autoship Products under this Agreement, I understand to do so within the period notified by OV (i.e. 7 days). If I have elected to have the Autoship Products delivered or shipped to a delivery address but fail to take delivery of the Autoship Products on the date OV has notified me, I understand that no re-delivery shall be made by OV and I understake to collect the Autoship Products from OV or pay for extra shipping fee charged by shipper. 如本人根據本合約選擇自動領取·本人明白本人需於機滙指定的期間內(即7天內)到取。如本人選擇送貨至某一指定地址·但本人未能按機滙通知本人的送貨日收取自動購貨產品·本人明白機滙不會再送貨·本人同意親蒞機滙提取自動購貨產品或繳付額外送貨的費用。
- 4. I understand and agree that the products which I order on a monthly basis for my Autoship Program may be either temporarily unavailable or permanently discontinued. Organic Vision reserves the right to (a) alter the formula or packaging of our products; (b) temporarily suspend the sale of any given products; (c) permanently stop the sale or production of any given products. Under such circumstances, I must purchase 680 BV worth of other products. 本人明白並同意本人每月按計劃購貨時,部份產品有可能暫時或永久終止供應。機智滙集有限公司有權:(a)變更產品配方或重新包裝產品;(b)暫時停止售賣現有產品;(c)永久終止售賣或生產現有產品。在這些情況下,本人須選購其他產品以符合業績額680BV或以上的要求。
- 5. I understand and agree that the price of the Autoship Products under this Agreement may change due to repackaging, improvements or other reasons. When such price changes occur, OV shall notify me of any price change and, unless I direct OV in writing to do otherwise by serving OV prior written notice in the prescribed format before my monthly payment to take effect the next purchase, OV shall continue to send me the Autoship Products at the new price and I shall be deemed to be agreeing to purchase the Autoship Products at the new price. 本人明白並同意自動購貨產品的價格可能基於貨品重新包裝、改良或其他因素而出現變更。如貨品價格需作改動,機滙將通知本人有關價格的調整,除非機滙於某一個月的扣數日前收到本人合乎機滙格式的通知,於下次另作安排,否則機滙將根據調整後之價格繼續本人提供自動購貨產品,而本人亦將視為同意以調整後之價格購買預選產品。
- 6. I understand and agree that my termination of this Agreement belonging to me during the period of this Program shall result in the revocation of the discount or free delivery received under this Program and the total amount of the discount given and the worth of the delivery will be directly refunded to OV by me or shall be automatically charged to the credit card. - 7.1 understand and agree that OV is entitled to terminate this Agreement without prior notice if I breach any of these Terms and Conditions. If this Agreement is terminated for whatever reason, I may re-apply from Backoffice or apply to OV to join this Program again by submitting a new OV Autoship Program Registration Contract which application may be accepted or rejected by OV at its sole discretion. If OV accepts such re-application, OV is entitled to require me to first pay to OV the total amount of the discount previously enjoyed by me if unpaid and OV is entitled to impose any further condition that OV may deem fit. 本人明白並同意,如本人違反此等條款及規章的任何一項,機 滙有權毋須作事前通知而解除本合約。如本合約因任何理由而被終止,本人可從電子商務中心或向機滙遞交一份新的自動購貨計劃申請合約,申請重新參加本計劃, 唯機滙絕對有權接受或拒絕本人申請。如機滙接受本人重新參加的申請,機滙有權要求本人先支付本人之前享有的優惠折扣及送貨服務費用之總數的欠款,機滙亦有全權額外要求本人符合其他條件。
- 8.1 understand and agree that if I do not wish this Agreement to be automatically renewed under the same terms and conditions at its expiry date, OV must receive my written notification not to renew 30 days prior to the expiry date of this Agreement, otherwise, OV has the right to automatically renew my Autoship made under this Program for a further twelve (12) months under the same terms and conditions of this Agreement 本人明白並同意·若本人不希望本計劃於期滿日後自動續期·機滙必須於期滿30日前接到本人書面通知·取消本計劃。如本人未能及時通知·則機滙有權根據本合約之條件及規章於期滿日起自動續期十二(12)個月。
- 9. I understand and agree this Agreement does not supersede or modify in any way the terms and conditions of my Independent Distributor Agreement or their amended version entered into with OV. 本人明白並同意本合約於任何情況下均不會取代或修訂本人與機滙簽訂的獨立直銷商協議(及其更改版本)的任何條件和規章。
- 10. All Autoship Products ordered under this Program can be refunded/replaced if it meets the requirements set out in Organic Vision's Policies and Procedues (see). 透過本計劃所購買的自動購貨產品·不接受退貨換款 (但可依機滙政策與程序規則更換同一產品)·除非機滙另作決定。
- 11. OV has the right to remind me to make any amendments and pay for my Next Autoship. 機滙有權提醒及通知本人有關修改自動購貨產品及繳付下次自動購貨等事宜。
- 12. OV has the right to edit this Agreement from time to time and to notify me of any policies and procedures related to this Program prescribed by OV from time to time ("OV AutoShip Program Policies and Procedures") and I shall be deemed to agree to such amendment and OV AutoShip Program Policies and Procedures unless OV receives my written objection before the expiry of the notice period. 本人明白機滙有權修改本合約.及通知本人關於機滙訂立任何與本計劃有關的政策和程序 (「機滙」自動購貨計劃政策及程序) 及其修改。除非機滙於通知期內收到本人書面反對.否則本人將被視為同意「機滙」自動購貨計劃政策及程序及其有關修訂。自動購貨等事宜。
- 13. This Agreement is written in both Chinese and English versions. In case of any inconsistency between the two versions, the English version should prevail. 本協議有中、英文兩個版本·若兩版本有任何差異·以英文版本為準。
- 14. In this Agreement, "Working Days" means the days that banks in Hong Kong are open for business, other than Saturdays. When certain action to be performed on a day that falls on a non-Working Day, the action shall be performed by the following Working Day. A notification to be given to me by OV under this Agreement may be given in writing or verbally or by electronic means. If notice is given to me in writing, it shall be deemed received when posted to my address last known to OV, if verbally, when a message is sent to my voicemail of my telephone or mobile phone number last known to OV; if sent to me by electronic means, when transmitted to my email address last known to OV or transmitted to me by other electronic means. - 15. Failure by OV to take action against me for any breach of this Agreement should not be a waiver of OV's right of action in the future. 若直銷商違反本合約和「機滙」自動購貨計劃政策及程序之任何條款,而機滙未有採取行動,並不表示機滙放棄日後要求本人履行之權利。
- 16. This Agreement and the OV AutoShip Program Policies and Procedures, both as amended from time to time, shall be the final document describing the understanding and agreement regarding this Program between OV and me. If there is any discrepancy between any clause of this Agreement or the OV Autoship Program Policies and Procedures and the oral interpretation made to me by another Independent Distributor or an employee of OV, the clause of this Agreement or, as the case may be, of the OV Autoship Program Policies and Procedures shall prevail. 本合約及「機滙」自動購貨計劃政策及程序為直銷商和機滙之間關於本計劃的最終協議。如本合約的條款或「機滙」自動購貨計劃政策及程序的條款與機滙其他獨立直銷商或機滙職員所作之口頭說明有任何不同,概以本合約條款和有關的「機滙」自動購貨計劃政策及程序條款為準。
- 17. If any clause of this Agreement or of the OV AutoShip Program Policies and Procedures is declared invalid or unenforceable, only that clause is invalid or unenforceable. The invalidity or unenforceability shall not affect the remainder of this Agreement or the OV AutoShip Program Policies and Procedures. 如本合約或「機滙」自動購貨計劃政策及程序之任何條款被宣稱無效或無法強制執行,則僅限於該條文,不影響其他條文。
- 18. This Agreement shall be governed by the Laws of the Hong Kong Special Administrative Region. 本合約以香港特別行政區法律管轄。
