



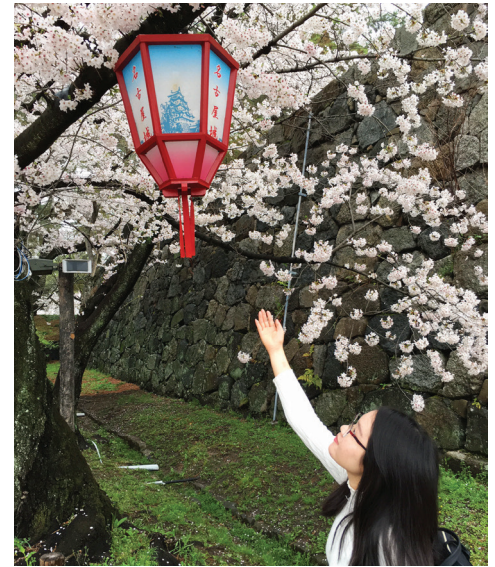
NAGOYA SAKURA TOUR
